CONDITIONS OF ENTRY

- 1) Only members of the KHFBFS may enter sheep.
- 2) All sheep must be registered and have Society ear tags. Entries will not be accepted unless the ear tag corresponds with that recorded in the relevant flock book. Lambs must have official ear tags.
- 3) The Vendor must ensure that ALL sheep have been previously registered prior to entry to the Sale. In addition all sheep must be identified in accordance with current Defra regulations (or equivalent authority).
- 4) Sheep must conform to KHFBFS standards. Please refer to the breed standard set out in the flock book. (Copies of the breed standard are available from the Administrator if required)
- 5) Sheep must be correct in mouth and udder & free from all signs of lameness & any contagious or infectious diseases.
- 6) Yearling ewes must not show more than two broad teeth. Ewes aged 2 years and over showing forward teeth must be declared at the time of sale otherwise they are returnable.
- 7) All in lamb ewes and in lamb yearling ewes must be scanned in lamb prior to the sale and the Society will provide an approved scanner to check sheep on the morning of the sale. Ewe lambs will not be scanned.
- 8) All vendors must have any licences or other documentation required by Defra (or equivalent authority). Failure to present this will result in exclusion from the sale. Vendors must also be aware of, and follow, all current Defra instructions regarding livestock sales.
- 9) No entry fees will be refunded.
- 10) No late or verbal entries will be accepted.
- 11) Vendors are responsible for the accuracy of all information given regarding their sheep.
- 12) No substitutes will be allowed unless a catalogued sheep is found to be not in lamb, then a substitute may be submitted to the Administrator, no later than 7 days prior to the sale.
- 13) All sheep must be penned in catalogue order and sold as catalogued.
- 14) All sheep must be clearly identified with the relevant lot number.
- 15) Whilst every care will be taken in the preparation of the catalogue, neither the KHFBFS nor the Auctioneers can be held responsible for errors.
- 16) Members are responsible for obtaining their own official ear tags.
- 17) Vendors will not be allowed to enter more than 12 sheep in a run. Further runs of 12 will be balloted in the same way. If the vendor wishes Ewes/Ewe Lambs can be entered and sold as pairs or multiples.
- 18) Vendors can enter a photo of the lot, sire/dam or sire used. Photos will be half a page in B&W, one photo can be listed for more than one lot if the same sire is used for each lot they are in lamb to. Only one photo is allowed per lot. Photos will be charged at £20 each and can have up to 15 words listed below the photo. Please provide this information with entries to the administrator.
